DON'T GET TICKETED - NEW DC LAWS AND ENFORCEMENT

New Law: Shut the Front Door

This summer, the DC Department of Energy & Environment (DDOE) will enforce a new law requiring commercial properties to keep their windows and doors closed when running the air conditioner. The law was passed by the Council of the District of Columbia in 2016 to help reduce the demand on the city's electrical grid. Fines start at \$100 and increase to \$800 after the 3rd offense.

Enforcement: Signage Enforcing

DDOT is ticketing businesses for locating "A-Frame" signs (sandwich boards) more than 3 feet from the storefront. Signs cannot exceed 3x3 feet and DDOT requires at least 6 feet of unobstructed sidewalk. Fines start at \$150 and can go up to \$2,000 after the 4th violation.
